# General information

#### Order / Changes / Cancellation

For a perfect service, we ask you to contact us as soon as possible. Of course, we are able to arrange your service even at the last minute. However, we would like to point out that it often takes at least 48 hours to obtain the goods from our suppliers if they are not in stock.

For the same reasons, any change in the number of participants must be communicated to us at least 48 hours in advance. In the case of a last minute reduction in the number of guests, the number confirmed 48 hours in advance is decisive for the billing. In any case we will do our best to satisfy your requests.

In the event of cancellation no later than 48 hours before the date of the event, we reserve the right to charge the costs incurred up to the time of cancellation.

#### **Pricing policy**

All our prices are inclusive of VAT, excluding service personnel costs unless otherwise specified. We will be happy to provide you with an estimate for all your events based on the service prices below.

#### 1. Scope and definitions

These general terms and conditions govern the legal relationship between the guest/client/organiser, hereinafter referred to as the client, and the establishments of the ZFV Group. In addition to these general terms and conditions, other provisions and booking conditions may apply. In the event of any discrepancies between the order and these General Terms and Conditions, the provisions set out in the order confirmation shall take precedence. The rules and regulations of the respective venue are an integral part of these general terms and conditions.

#### 2. Service

The ZFV Group undertakes to provide the scope of services in accordance with the order confirmation with the customer. The ZFV Group reserves the right to make minor changes to its services in agreement with the customer in the event of short-term changes in the market offer (e.g. missing goods, massive price increases), and undertakes to perform the order in the same way.

#### 3. Agreement

The order shall be deemed to have been placed when the offer or order confirmation has been reconfirmed by the customer. If no written form has been agreed between the parties, an oral agreement shall also serve as a reconfirmation. If the booking is made by a third party, the latter shall also become a partner, irrespective of a valid authorisation by the customer, and shall be liable, in addition to the customer, for all obligations arising from the order as a joint and several debtor.

#### 4. Advertising

Newspaper advertisements and any other commercial advertising of events in ZFV Group establishments require the prior consent of the ZFV Group.

#### 5. Change in the number of participants

The agreed number of participants is binding at the latest 2 working days before the event. This number of participants is the basis for invoicing. Participants who do not show up will be charged the full cost.

#### 6. Cancellation of events and bookings

Final orders can be cancelled free of charge up to and including the 3rd day before the event. Excluded from this are expenses already incurred up to this point in time for third parties which have been incurred by the ZFV Group at the request of the customer. From the 2nd day before the event, the actual costs incurred will be charged.

#### 7. Customer's responsibility

The customer is liable for any damage (personal injury and/or property damage), even if he/she is not directly at fault (e.g. theft, accident). This also applies to damage caused by third parties. The ZFV Group is not liable for accidents of event participants, provided they are not caused by employees of the ZFV Group. The ZFV Group accepts no liability for the services of third parties.

#### 8. Prices and payment terms

Prices confirmed in writing are valid. They are in Swiss francs, including VAT. Invoices are payable within 20 days of the invoice date. Personal cheques are not accepted. Customers domiciled abroad must pay 100% of the amount indicated in the order confirmation 7 working days before the event. If advance payments confirmed in writing are not paid on time, the ZFV Group is entitled to withdraw from the contract and to charge the customer for any expenses incurred up to that point. If the customer is not also the organiser, he/she is jointly and severally liable for the full amount of the invoice. The ZFV Group reserves the right to make information available to third parties for the purpose of checking creditworthiness and to transfer this information to third parties in the case of outstanding claims, with the processing costs incurred being charged to the amount due.

#### 9. Cancellation by the ZFV Group

In the event of force majeure, conversion projects, by order of the authorities and in the event of non-compliance with the contractually agreed advance payment, the ZFV Group is entitled to terminate the contract without charge. If the ZFV Group has justified reasons to believe that the event threatens to jeopardise the proper functioning, safety or reputation of the establishment, it may terminate the contract without compensation.

#### 10. Applicable law and jurisdiction

These terms and conditions are governed by Swiss law. The place of jurisdiction is exclusively Zurich.
